*Why have the Annual Meeting if we are not having the Conference?*

- The annual meeting is THE opportunity every year for the International Board of Directors (IBOD) and the trusts to share information with the members. Although it was not possible to have the traditional International Conference this year, the IBOD determined that it was important to have the Annual Meeting, and that technology was available to make it possible to hold the meeting online.
- Additionally, The 99s bylaws and standing rules require an annual meeting.

*Many chapters and sections have used Zoom for their meetings. Will we use Zoom for the Annual Meeting?*

- Zoom is a highly

effective tool for a variety of types of meetings. It is great that many of the sections and chapters are using the tool for their meetings.

- The international annual meeting is more formal and structured than many of the section or chapter meetings, and the meeting adheres to parliamentary procedure and protocol.
- We created a set of technology requirements, and matched them to existing technology tools, such as Zoom, GoToWebinar, BroadNet, and others.
- After reviewing, debating pros and cons, we chose GoToWebinar as the technology for the meeting. In addition to fulfilling the requirements, there is the added

advantage that The 99s uses this software for our webinars.

*Why is the time of the meeting set for Pacific Daylight Time?*

- July 11 at 8:30 am PDT (15:30 GMT) is the date and time that the in-person annual meeting was scheduled at the conference in Long Beach. This is the date and time that was announced prior to the cancellation of the Conference.
